The Glencoe Landfill site is situated in the uMzinyathi District Municipality, KwaZulu-Natal between Ladysmith, and Newcastle. The landfill is located on the southern boundary of Glencoe Townlands and shares a common boundary with Uithoek 1335.

Scope of Work:


- Water sample collection from the predefined surface and groundwater monitoring points.
- Safe transportation of samples to a SANAS accredited laboratory.
- Data management and analysis of field data and chemistry results.
- Determine the nature and extent of contamination and indicator trends of groundwater.
- Reporting of results and historical water trends (where available).
- Make recommendation on remedial action required for water contamination (where necessary).
- The development of a geohydrological model of underground water at the site.
- There are four water monitoring boreholes that need to be sampled at the site.
- A sample from cell one and cell two of the leachate ponds are also required to be analysed.
- A sample from the contaminated stormwater dam must also be analysed (if it has water in it).
- Samples from upstream and downstream monitoring points must also be analysed.

P_s = Points scored for price of tender under consideration

P_t = Price of tender under consideration

P_{max} = Price of highest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

(a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
